

Fiscal Year 2023 Federal Funding Increases

- Title I funding for disadvantaged students rose 4.8%, from \$17.5 billion to \$18.4 billion year over year.
- Title III funding for English language acquisition programs increased by 7%, from \$831 million to \$890 million.
- Title IV block grant funds for academic enrichment increased by 7.7%, from \$1.3 billion to \$1.4 billion.



Fiscal Year 2024 Proposals for K-12 (selected states)

- +9.9% New York
- +6.6% Indiana
- +5.0% Illinois
- +4.8% Florida
- +4.0% Georgia
- +1.8% Alabama
- +0.3% Mississippi
- -1.3% California



State Adoption Outlook (classroom implementation dates)

2023 2024

Florida – science Alabama – science, CTE

Idaho – world languages California – math (delayed)

Oklahoma – math Florida – world languages

Oregon – science Mississippi – math, social studies, arts

Tennessee – science, career tech, fine arts New Mexico – science

Tennessee – social studies




