

## **Federal Funding**

- ➤ COVID-19 Pandemic funding is available until Sept. 30, 2024. As of June 30, 2023, 57.7% of all ESSER relief funds had been spent by states & school districts. *More than* \$80 *billion remains available*
- Unlike the past several years, annual federal allocations (e.g. Title I) will be lower because of the new "budget caps"

## **State Funding**

- > FY 2024 increases are strong, but lower than the past two years
- > FY 2024 state budgets for K-12 education include:
  - Florida 8.9%
  - Pennsylvania 7.8%
  - Michigan 5%
  - Illinois 4.4%
  - Texas 1.2%
  - California -2%

- Science of reading
- Learning recovery
- > Parental rights, reviews of curriculum, other "culture wars" legislation
- School choice expansion
- > Early learning
- Math reform/science of math

## **Science of Reading**

- More than 80 "SoR" bills introduced at the state level. Significant bills:
  - Georgia (HB 538 enacted)
  - New Mexico (HB 481 enacted)
  - Virginia (HB 1526 enacted)
  - Ohio (HB 33 enacted)
  - Indiana (HB 1558 enacted)
  - Wisconsin (AB 321)
  - Illinois (SB 2243)
  - Oregon (HB 3198 enacted)
  - Michigan (SB 12 enacted)

### **Culture Wars**

- > Critical race theory, divisive concepts, LBGTQ/gender identity, SEL
- Parental rights, "academic transparency"
- > Impacts on education companies

#### Instructional Materials

- > Curriculum bills:
  - Literacy, math, media literacy, STEM, climate change education
- > State adoption:
  - Texas SB 1605 makes many significant changes to the state's adoption process

## **Summary**

- > State support for science of reading initiatives continues to grow. Science of math is emerging
- Culture wars legislation poses difficulties for vendors of content & curriculum
- > State K-12 funding remains positive. Federal funding will, for the most part, remain flat
- Congress will have little impact on K-12 policy issues in 2023 and 2024


